

## Blackbushe Air Day and Fly-In Ticket Terms & Conditions

In these Terms & Conditions, the "**Organiser**", "**Us**", "**Our**", or "**We**" means Blackbushe Airport Ltd and "**Event**" shall mean the Blackbushe Air Day scheduled for Saturday 15<sup>th</sup> June 2024.

Tickets to this Event are issued on behalf of the Organiser Blackbushe Airport Ltd and are subject to the following terms and conditions:

- 1. In addition to those terms and conditions outlined below, any attendee of the Event agrees to the terms and conditions outlined by our ticket agent Eventbrite here.
- 2. Nobody will be allowed admission to the Event without a valid ticket, exhibitor pass, or fly-in participant entry PPR.
- 3. For the safety of people at the Event, the venue management and the Organiser reserve the right to refuse admission and conduct security searches as they deem appropriate.
- 4. All tickets or passes should be checked on purchase, as mistakes cannot always be rectified.
- 5. Tickets may be refunded up until close of business on Friday 7<sup>th</sup> June 2024. Refunds will be issued at ticket face value less any fees payable to Eventbrite. Refunds will not be given after this date.
- 6. If the Event is rescheduled, the Organiser will give you the option to utilise your tickets for the rescheduled date or receive a full refund.
- 7. If the Event is cancelled by the Organiser, you will be offered a full refund for your tickets.
- 8. In the event that you are unable to attend due to any Covid-19 Government regulation or restriction introduced after the purchase date e.g. vaccine passports, you will not be entitled to a refund either in part or in full, but may nominate another person to transfer your ticket(s) to.
- 9. If the Event is rescheduled, changed, moved or cancelled the Organiser cannot be held responsible for any resulting costs you may incur for travel, accommodation and other related goods, services or compensation.
- 10. Defaced or altered tickets or passes will become void and the holder will be refused admission.
- 11. Tickets cannot be resold for commercial gain. If we have reason to believe that tickets have been re-sold, they will be invalidated, and the holder will be refused admission.
- 12. We may restrict the sale of tickets to a maximum number per person (allocation). We reserve the right to cancel tickets bought in excess of this allocation.
- 13. The Organiser reserves the right to alter or vary the content or timing of any part of the Event in circumstances beyond

The Organiser will not be responsible for any loss, damage, death or injury howsoever caused unless (i) the relevant party has breached its legal obligations; and (ii) such loss or damage is a direct and reasonably foreseeable result of the breach. For the avoidance of doubt, the Organiser will not be responsible for the actions of any third party, including, but not limited to, the exhibitors.
- 16. The Event is planned to take place outdoors and it will take place regardless of weather conditions (unless deemed unsafe by the Organiser). There are no refunds for bad weather, or for any change in the planned exhibitors or activities resulting from bad weather. We strongly advise that you come dressed appropriately for an outdoor Event.
- 17. The Organiser does not accept any responsibility for any loss or damage to personal property brought to the Event.
- 18. Visitors may be filmed, photographed or sound recorded for broadcast, publication or security purposes whilst at the Event by the Organiser and our trusted sponsors and partners.
- 19. Visitors are not permitted to bring animals to the Event with the exception of guide, assistance and hearing dogs.
- 20. Please check your route prior to travelling to ensure you arrive on time. The Organiser is not responsible for any delays due to travel disruptions.
- 21. Onsite parking is limited and for this reason parking passes must be purchased in advance. No entry will be permitted to vehicles arriving without prebooked parking. Attendees are encouraged to travel on foot wherever possible.
- 22. In accordance with the law, visitors aged under 18 are not permitted to purchase/sample alcoholic drinks.
- 23. The relevant United Kingdom law will apply to these Terms and Conditions and the relevant courts of the United Kingdom will have exclusive jurisdiction in relation to the Terms and Conditions.
